SECURITY AGREEMENT

SECURITY AGREEMENT dated as of June 9, 2004 made by Whitmire Micro-Gen Research Laboratories, Inc., a Delaware corporation (the "Grantor") to The Royal Bank of Scotland PLC, as Security Trustee (the "Security Trustee") for the Finance Parties (as defined in the Facilities Agreement referred to herein).

PRELIMINARY STATEMENTS

(1) Whitmire Holdings, Inc. (the "Company" or the "Original Borrower") and Sorex Holdings Limited (the "Parent") have entered into a Facilities Agreement, dated as the date hereof, with the Original Guarantors, the Arranger, the Original Lender, the Agent and the Security Trustee, each as defined therein (said agreement, as it may hereafter be amended, amended and restated, replaced, novated, supplemented or otherwise modified from time to time, being the "Facilities Agreement").

(2) The Grantor, as Guarantor pursuant to the Facilities Agreement, has guaranteed the obligations of the Obligors under the Finance Documents whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, fees, premiums penalties, indemnifications, contract causes of action, costs, expenses or otherwise (the "Obligations").

(3) Pursuant to the Facilities Agreement, the Grantor is entering into this Agreement in order to grant to the Security Trustee for the ratable benefit of the Finance Parties a security interest in the Collateral (as hereinafter defined).

(4) The Parent and The National Westminster Bank Plc as the lender thereunder (the "Ancillary Lender") have entered into an ancillary financing letter (the "Original Ancillary Facility") whereby the Ancillary Lender will make available to the Parent an overdraft facility.

(5) The Grantor is the owner of the shares of stock or other equity interests (the "Initial Pledged Equity") set forth on and as otherwise described in Schedule II hereto and issued by the Persons named therein.

(6) The Grantor has security entitlements (the "Pledged Security Entitlements") with respect to all the financial assets (the "Pledged Financial Assets") credited from time to time to the accounts (the "Securities Accounts") described in Schedule V hereto.

(7) The Finance Parties have agreed that their respective rights to the Collateral are to be governed by an Intercreditor Agreement, dated as of the date of this Agreement, among the Parent, the Original Borrower, the other Obligors, the Senior Lender, the Senior Agent, the Senior Security Trustee, the Ancillary Lender, the Original Hedge Counterparty, the Junior Lenders, the Junior Security Trustee, the Junior Agent and the Shareholders, each as defined therein (as amended, amended and restated, replaced, novated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement").

(8) The Grantor has certain deposit accounts (the "Deposit Accounts") with banks, in the name of the Grantor and subject to the terms of this Agreement, as described in Schedule VI hereto.

(9) It is a condition precedent to the making of the Facilities under the Facilities Agreement and the loan under the Original Ancillary Facility that the Grantor shall have granted the assignment and security interest and made the pledge and assignment contemplated by this Agreement.

(10) The Grantor will derive substantial direct and indirect benefit from the transactions contemplated by the Finance Documents.

(11) Terms defined in the Facilities Agreement and not otherwise defined in this Agreement are used in this Agreement as defined in the Facilities Agreement. Further, unless otherwise defined in this Agreement or in the Facilities Agreement, terms defined in Article 8 or 9 of the UCC (as defined below) are used in this Agreement as such terms are defined in such Article 8 or 9. "UCC" means the Uniform Commercial Code as in effect, from time to time, in the State of Missouri; *provided, that*, if perfection or the effect of perfection or non-perfection or the priority of any security interest in any Collateral is governed by the Uniform Commercial Code as in effect in a jurisdiction other than the State of Missouri, "UCC" means the Uniform Commercial Code as in effect from time to time in such other jurisdiction for purposes of the provisions hereof relating to such perfection, effect of perfection or non-perfection or priority.

NOW, THEREFORE, in consideration of the premises and in order to induce the Finance Parties to make the Revolver and Term Loans under the Facilities Agreement, the Grantor hereby agrees with the Security Trustee for the ratable benefit of the Finance Parties as follows:

SECTION 1. Grant of Security. The Grantor hereby grants to the Agent, for the ratable benefit of the Finance Parties, a security interest in, the Grantor's right, title and interest in and to all assets of the Grantor, including without limitation the following, in each case, as to each type of property described below, whether now owned or hereafter acquired by the Grantor, wherever located, and whether now or hereafter existing or arising (collectively, the "Collateral"):

(a) all "inventory" as defined in the UCC, which is located anywhere, including without limitation in the United States, in all of its forms including, without limitation, (i) all raw materials, work in process, finished goods and materials used or consumed in the manufacture, production, preparation or shipping thereof, (ii) goods in which the Grantor has an interest in mass or a joint or other interest or right of any kind (including, without limitation, goods in which the Grantor has an interest or right as consignee) and (iii) goods that are returned to or repossessed or stopped in transit by the Grantor, and all accessions thereto and products thereof and documents therefor, and all software related thereto, including, without limitation software that is imbedded in and is part of the inventory (any and all such property being the "Inventory");

(b) the following (the "Security Collateral"):

(i) the Initial Pledged Equity and the certificates, if any, representing the Initial Pledged Equity, and all dividends, distributions, return of capital, cash,

instruments and other property from time to time received, receivable or otherwise distributed in respect of or in exchange for any or all of the Initial Pledged Equity and all subscription warrants, rights or options issued thereon or with respect thereto;

(ii) all additional shares of stock and other equity interests of or in any issuer of the Initial Pledged Equity, or any successor entity from time to time acquired by the Grantor in any manner, and all shares of stock and other equity interests of or in any other entity from time to time acquired by the Grantor (such shares and other equity interests, together with the Initial Pledged Equity, if any, being the "Pledged Equity") and the certificates, if any, representing such additional shares or other Equity Interests, and all dividends, distributions, return of capital, cash, instruments and other property from time to time received, receivable or otherwise distributed in respect of or in exchange for any or all of such shares or other equity interests and all subscription warrants, rights or options issued thereon or with respect thereto;

(iii) the Securities Accounts of the Grantor, all Pledged Security Entitlements with respect to all Pledged Financial Assets from time to time credited to such Securities Accounts, and all Pledged Financial Assets, and all dividends, distributions, return of capital, interest, cash, instruments and other property from time to time received, receivable or otherwise distributed in respect of or in exchange for any or all of such Pledged Security Entitlements or such Pledged Financial Assets and all subscription warrants, rights or options issued thereon or with respect thereto; and

(iv) all other "investment property" as defined in the UCC, including, without limitation, all (A) "security" as defined in the UCC, whether certificated or uncertificated, (B) "security entitlements" as defined in the UCC, and (C) all "securities accounts" as defined in the UCC, in which the Grantor has now, or acquires from time to time hereafter, any right, title or interest in any manner, and the certificates or instruments, if any, representing or evidencing such investment property, and all dividends, distributions, return of capital, interest, value, cash, instruments and other property from time to time received, receivable or otherwise distributed in respect of or in exchange for any or all of such investment property and all subscription warrants, rights or options issued thereon or with respect thereto;

(c) the Deposit Accounts and all other "deposit accounts" as defined in the UCC from time to time established, of the Grantor and in each case, all funds and other property from time to time received, receivable or otherwise distributed in respect of or in exchange for any or all of such funds, and all certificates and instruments, if any, from time to time representing or evidencing the Deposit Accounts and such deposit accounts (the "Account Collateral");

(d) all books and records, including, without limitation, customer lists, credit files, computer programs software, printouts and other computer materials and records, of the Grantor pertaining to any of the Collateral;

(e) all "accounts", including health-care-insurance receivables, if any, as defined in the UCC, in which the Grantor has now, or acquires from time to time hereafter, any right, title or interest in any manner (the "Accounts");

(f) all "chattel paper" as defined in the UCC, in which the Grantor has now, or acquires from time to time hereafter, any right, title or interest in any manner (the "Chattel Paper");

(g) all "instruments," including promissory notes, and all "documents," as each is defined in the UCC, in which the Grantor has now, or acquires from time to time hereafter, any right, title or interest in any manner (the "Instruments");

(h) all "general intangibles," as defined in the UCC ("General Intangibles"), including all payment intangibles (including, without limitation, payment intangibles arising under any of the Intra-Group Loan Agreements), software, patents, patent applications (and patents arising therefrom), trademarks, trademark applications (and marks registered therefrom), copyrights and similar intellectual property rights, and all application and registrations therefor (as to such General Intangibles, the "Intellectual Property Collateral");

(i) all "letter-of-credit rights" as defined in the UCC (the "Letter of Credit Rights");

(j) all "equipment" as defined in the UCC, including software, whether or not the same constitutes embedded software, used in the operation thereof (the "Equipment");

(k) all "fixtures" as defined in the UCC (the "Fixtures");

(l) all rights to merchandise and other goods, including rights to returned or repossessed goods and rights of stoppage in transit, which is represented by, arises from, or relates to any of the foregoing;

(m) all personal property and interests in personal property of the Grantor of any kind or description now held by any secured creditor or at any time hereafter transferred or delivered to, or coming into the possession, custody or control of, any secured creditor, or any agent or affiliate of any secured creditor, whether expressly as collateral security or for any other purpose (whether for safekeeping, custody, collection or otherwise), and all dividends and distributions on or other rights in connection with any such property;

(n) all supporting evidence and documents relating to any of the above-described property, including, without limitation, computer programs, disks, tapes and related electronic data processing media, and all rights of the Grantor to retrieve the same from third parties, written applications, credit information, account cards, payment records, correspondence, delivery and installation certificates, invoice copies, delivery receipts, notes and other evidences

of indebtedness, insurance certificates and the like, together with all books of account, ledgers, and cabinets in which the same are reflected or maintained;

(o) all Receivables;

(p) all accessions and additions to, and substitutions and replacements of, any and all of the foregoing; and

(q) all Proceeds and products of the foregoing, and all insurance of the foregoing and proceeds thereof, all of the foregoing Collateral.

For purposes of this Agreement, the term "Receivables" means all rights to the payment of a monetary obligation, whether or not earned by performance and whether evidenced by an Account, Chattel Paper, Instrument, General Intangible, or otherwise.

SECTION 2. Security for Obligations. (a) This Agreement secures, in the case of the Grantor, the payment and performance of the Obligations now or hereafter existing under the Finance Documents.


SECTION 3. Grantor Remains Liable. Anything herein to the contrary notwithstanding, (a) the Grantor shall remain liable under the contracts and agreements included in the Grantor's Collateral to the extent set forth therein to perform all of its duties and obligations thereunder to the same extent as if this Agreement had not been executed, (b) the exercise by the Security Trustee of any of the rights hereunder shall not release any Grantor from any of its duties or obligations under the contracts and agreements included in the Collateral, and (c) no Finance Party shall have any obligation or liability under the contracts and agreements included in the Collateral by reason of this Agreement or any other Finance Document, nor shall any Finance Party be obligated to perform any of the obligations or duties of the Grantor thereunder or to take any action to collect or enforce any claim for payment assigned hereunder.

SECTION 4. Delivery and Control of Security Collateral. So long as any Obligation of any Obligor under any Finance Document shall remain unpaid or unperformed:

(a) All certificates or instruments representing or evidencing Security Collateral shall be delivered to and held by or on behalf of the Security Trustee pursuant hereto and shall be in suitable form for transfer by delivery, or shall be accompanied by duly executed instruments of transfer or assignment in blank, all in form and substance reasonably satisfactory to the Security Trustee. The Security Trustee shall have the right at any time, if it believes such is reasonably necessary or proper to better preserve and protect its rights hereunder, and with notice to the Grantor, to transfer to or to register in the name of the Security Trustee or any of its nominees any or all of the Security Collateral, subject only to the revocable rights specified in Section 9. In addition, the Security Trustee shall have the right at any time to exchange certificates or instruments representing or evidencing Security Collateral for certificates or instruments of smaller or larger denominations.

IN WITNESS WHEREOF, the Grantor has caused this Agreement to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
