RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE (TRADEMARK) is given as of June 2, 2004 to Standard Parking Corporation, f/k/a APCOA/Standard Parking, Inc., a Delaware Corporation ("SPC") located at 900 North Michigan Avenue, Suite 1600, Chicago, Illinois 60611, by Wilmington Trust Company, having an office at Rodney Square North, 1100 North Market Street, Wilmington Delaware 19890, as trustee and collateral agent (hereinafter, in such capacity as the "Agent") for itself and the several holders (the "Holders") of the 14% Senior Subordinated Second Lien Notes due 2006 (the "Notes") issued by Standard Parking Corporation pursuant to an indenture dated as of January 11, 2002, as follows:

WHEREAS, Agent and SPC entered into a Trademark Collateral Security and Pledge Agreement, dated as of January 11, 2002 (the "Security Agreement"), pursuant to which SPC granted to Agent a security interest in and made a collateral assignment of all of SPC's right, title and interest in and to the Trademark Rights (as defined in the Security Agreement) referred to in Schedule A thereto, and identified in Schedule 1 to this RELEASE, and all good will associated with the Trademark Rights; and,

WHEREAS, SPC has promptly paid and performed all its Obligations under the Security Agreement and Agent desires to release its security interests in and liens upon the Trademark Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby releases its lien on and security interest in all SPC's right, title and interest in and to the Trademark Rights and reassigns any and all interest it may have in such Trademark Rights to SPC.
