


WHEREAS, Assignor wishes to herein memorialize said assignment and transfer of the Trademarks to Assignee.



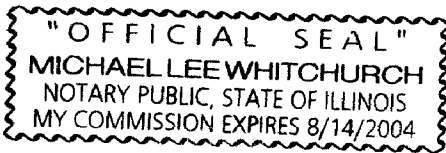
