TRADEMARK AND COPYRIGHT ASSIGNMENT

THIS AGREEMENT is made by and between Judy Lynn Schwimmer, of 3501 Sawtelle Boulevard, Los Angeles, California 90066 (hereinafter referred to as "Assignor"), and MeadWestvaco Corporation, a corporation of the State of Delaware having its Consumer and Office Products Group with a principal place of business at Courthouse Plaza Northeast, Dayton, Ohio 45463, (hereinafter referred to as "MeadWestvaco");

WHEREAS, Assignor is the owner of the entire right, title and interest in the trademark "COORDINATION GRAPH PAPER (and Design)" (hereinafter called the "Trademark"), and in United States Trademark Registration No. 1,946,503 relating thereto (hereinafter the "Trademark Registration"), and in the goodwill associated therewith;

WHEREAS, Assignor is the author and proprietor of the entire right, title and interest in the following works of authorship and the copyrights therein (hereinafter the "Copyrights"):

"COORDINATION Graph Paper Cover Page and Pad," also referred to as "Combination Pad;"

"COORDINATION Graph Paper and Pad," also referred to as "the First Quadrant Coordinate Axes;"

and in Copyright Registrations Nos. VA 671-286 and 671-287 relating to the aforesaid works, respectively (hereinafter the "Copyright Registration");

AND WHEREAS, MeadWestvaco is desirous of obtaining the entire right, title and interest in the Trademark, the Trademark Registration, the goodwill associated with the Trademark, the Copyrights and the Copyright Registrations;

NOW, THEREFORE, Assignor and MeadWestvaco agree as follows:

1. Assignor hereby sells, transfers, and assigns to MeadWestvaco, its successors and assigns, her entire right, title and interest in the Trademark, the Trademark Registration, and in all good will associated therewith.
2. Assignor hereby sells, transfers, and assigns to MeadWestvaco, its successors and assigns, her entire right, title and interest in the Copyrights and the Copyright Registrations.

3. In consideration for the assignments set forth above, MeadWestvaco will pay to Assignor the sum of Ten Thousand and no/100 Dollars (\$10,000.00), to be paid by MeadWestvaco within thirty (30) days of execution of his Agreement.
4. Assignor further agrees that she will, upon the reasonable request of MeadWestvaco and at its expense, sign all papers and perform all acts that MeadWestvaco may reasonably believe to be necessary in connection with the assignments made herein or the Trademark, Copyrights, or Registrations.




