Pursuant to the provisions of RCW 23B.10 of the Washington Business Corporation Act, InterNAP Corporation, a Washington corporation, hereby adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is:

InterNAP Corporation

SECOND: Article I of the articles of incorporation is amended to read in its entirety as follows:

ARTICLE I

The name of the corporation is **InterNAP Network Services Corporation** (the "Corporation").

THIRD: Part C of Article II of the articles of incorporation, setting forth the rights, preferences and restrictions of Preferred Stock, is amended to read in its entirety as set forth on Exhibit A attached and made a part hereof.


FOURTH: The amendments do not provide for an exchange, reclassification or cancellation of any issued shares.
