### RELEASE OF SECURITY INTEREST OF TRADEMARKS


This Release of Security Interest (this "Release") is dated as of April 16, 2004. Reference is hereby made to that certain trademark security agreement dated as of August 7, 2000 by and between Continental Farms, Ltd., a Florida limited partnership ("Grantor"), and Bankers Trust Company, recorded with the United States Patent and Trademark Office on September 7, 2000 (Reel/Frame No. 2155/0865) and that certain trademark security agreement dated as of November 3, 2000 by and between Grantor and Bankers Trust Company, recorded with the United States Patent and Trademark Office on November 22, 2000 (Reel/Frame No. 2238/0423) (collectively the "Trademark Grants").

Bankers Trust Company hereby notifies, acknowledges to and agrees with Grantor that the security interest granted by Grantor to Bankers Trust Company in the collateral set forth in the Trademark Grants (the "Trademark Collateral") including, without limitation, the security interest granted in the trademarks listed on the attached Schedule A, is terminated and released, and that Bankers Trust Company hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Trademark Grants in the Trademark Collateral.

Bankers Trust Company hereby agrees to take such further actions and to execute and deliver such further documents as Grantor may reasonably request to effect and evidence this Release, including, without limitation, the execution and delivery of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Trademark Collateral subject, in each case to the Grantor's prior payment in full to Bankers Trust Company of its costs and expenses (including reasonable fees and disbursements of counsel) incurred in connection therewith, provided, however, that Bankers Trust Company shall not be required to take any action which exposes Bankers Trust Company to personal liability or which is contrary to applicable law. Grantor hereby agrees to record the chain of title accordingly with the United States Patent and Trademark Office.

IN WITNESS THEREOF, Bankers Trust Company has caused this Release to be duly executed and delivered by its duly authorized representative as of the date first above written.
