

WHEREAS, Assignor and its affiliated companies have assigned to Assignee, among other things, the entire business relating to and associated with the Marks as of the Effective Date; and


WHEREAS, Assignor is desirous of assigning and Assignee is desirous of obtaining all right, title and interest in and to the Marks.


