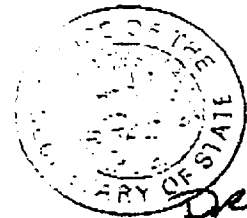

2. The Articles of Incorporation of said Corporation shall be amended to add the following provisions:


