**RELEASE OF SECURITY
INTEREST IN TRADEMARKS**

Dated as of May 24, 2004

Reference is made to (i) that certain Senior Credit and Guaranty Agreement dated as of October 31, 2003 (as this agreement may be amended, amended and restated, supplemented or otherwise modified or renewed from time to time, the "Senior Credit Agreement"), among DATA TRANSMISSION NETWORK CORPORATION, a Delaware corporation (the "Borrower"), DTN, LLC ("DTN"), the guarantors referred to therein, the several banks and other financial institutions from time to time parties to the Senior Credit Agreement (each a "Senior Lender" and collectively, the "Senior Lenders"), and WACHOVIA BANK, NATIONAL ASSOCIATION, as senior agent and senior collateral agent for the Lenders (in such capacities, respectively, the "Senior Agent" and the "Senior Collateral Agent"); (ii) that certain Senior Security and Pledge Agreement dated as of October 31, 2003 (the "Senior Security Agreement"), among the Borrower, DTN, Meteorlogix, LLC ("Meteorlogix") and the other the subsidiary guarantors referred to therein and the Senior Collateral Agent, pursuant to which, inter alia, Meteorlogix granted to the Senior Collateral Agent a security interest in all of its right, title, and interest in and to the trademarks and registrations listed on Schedule A hereto (the "Trademarks") and (iii) that certain Meteorlogix Supplement to the Senior Security Agreement, dated October 31, 2003, (the "Supplement"), which Supplement evidences the security interest of the Senior Collateral Agent in the Trademarks.

The Senior Collateral Agent hereby re-assigns and releases to Meteorlogix and terminates all right, title and interest that the Senior Collateral Agent has in and to the Trademarks and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Trademarks; the right to sue for past, present and future infringements, and all rights corresponding thereto; and all rights relating to any related trademarks or trademark applications existing in the past, present or future.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
