ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 18, 2004 (hereinafter, this "Assignment"), is made by CREDIT SUISSE FIRST BOSTON, CAYMAN ISLANDS BRANCH, as resigning Administrative Agent (the "Assignor") to SUNTRUST BANK, as successor Administrative Agent (hereinafter, the "Assignee");

WHEREAS, the Assignor acquired a security interest in the property described in that certain Trademark Security Agreement, dated as of April 30, 2003, among Ethyl Corporation, certain lenders from time to time parties thereto, and the Assignor, as recorded in the United States Patent and Trademark Office (the "USPTO") on June 5, 2003 on Reel 2759, Frame 0357, the property comprising all trademarks, trade names, corporate names, company names, business names, trade styles, service marks, certification marks, collective marks, logos and other source business identifiers, and all good will of the business associated therewith, now existing or hereafter acquired including those referred to in Schedule 1, all trademark licenses, and all proceeds of and rights associated with the foregoing (the property being collectively referred to herein as the "Trademark Collateral") (the "Trademark Agreement"); and

WHEREAS, the Assignor is resigning as Administrative Agent (as such term is defined in the Trademark Agreement) and the Assignee is being appointed as successor Administrative Agent thereunder; and


WHEREAS, the Assignor is desirous of assigning and the Assignee is desirous of acquiring said security interest in the Trademark Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby grants and conveys to the Assignee its full, exclusive, and entire security interest in the Trademark Collateral, and hereby assigns to the Assignee its full, exclusive, and entire right, title, and interest in the Trademark Collateral received under the collateral assignment of the Trademark Agreement and under the Trademark Agreement.


