

**AMENDMENT OF  
ARTICLES OF INCORPORATION  
OF  
THE CORPORATE PSYCHOLOGY CENTER, INC.  
(A Missouri Corporation)**

Pursuant to the provisions of The General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

1. The present name of the Corporation is The Corporate Psychology Center, Inc., the name under which it was originally organized.
2. An amendment to the Corporation's Articles of Incorporation was adopted by the shareholders on April 14, 2000.
3. Article Number 1 is amended to read as follows:

Article I

The name of the corporation is CAUSEWAY PUBLISHING COMPANY

4. Of the 5,000 shares of common stock outstanding, 5,000 of such shares were entitled to vote on such amendment.
