

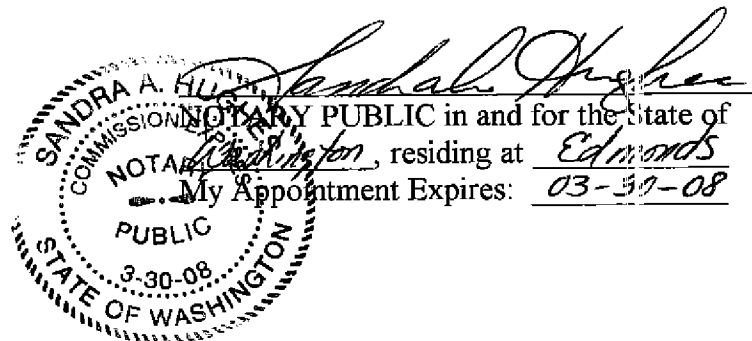

**NOTICE OF RESIGNATION**

WHEREAS, by a certain trust agreement (the "Trust Agreement"), dated as of the 6<sup>th</sup> day of November, 2002, between Washington Mutual Bank, FA, as trustor (the "Trustor"), and Washington Mutual Bank, FA, as general trustee (the "General Trustee"), and Wilmington Trust Company, a Delaware banking corporation, as administrative trustee (the "Administrative Trustee"), the Trustor created a trust; and

WHEREAS, pursuant to Paragraph IV(B) of the Trust Agreement, the Administrative Trustee may resign its trusteeship at any time for any reason by delivering to the Trustor notice in writing, which resignation shall be effective as of the future date and time specified in the notice or upon delivery of the notice if no such future effective date and time is specified in the notice;
