**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "Agreement"), effective as of the 1<sup>st</sup> day of June, 2001, (the "Effective Date"), is made by and between Everett Pad & Paper Company, a Washington corporation ("Assignor"), and ~~EPP Acquisition Co., a Nevada corporation~~ Everett Pad & Paper Co., LLC *liability company* ("Assignee").

**WITNESSETH:**

WHEREAS, Assignor has adopted or used and has registered or applied for registration of the trademarks listed on Exhibit A to this Agreement in connection with the goods listed thereon (the "Marks");

WHEREAS, Assignor and Assignee have entered into that certain Agreement of Purchase and Sale of Certain Assets of Everett Pad & Paper Company dated June 1, 2001, pursuant to which Assignor has agreed to assign and Assignee has agreed to acquire all of Assignor's right, title, and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof; and

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys unto Assignee all of Assignor's right, title and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof. The Marks are being assigned to a successor to the portion of Assignor's business to which the Marks pertain.
2. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.
