ASSIGNOR hereby warrants and covenants that it has the full power and authority to convey the rights, title and interests herein assigned, transferred and sold to **ASSIGNEE**, that it

has not executed and will not execute any agreement in conflict herewith, that it has not granted and will not grant any rights in conflict herewith, and that it will execute any and all other instruments which may be reasonably necessary to perfect and evidence the assignment of the property and rights herein conveyed.
