RELEASE AND REASSIGNMENT OF INTELLECTUAL PROPERTY

This **RELEASE AND REASSIGNMENT OF INTELLECTUAL PROPERTY** (this "Release and Reassignment") is made as of June 11, 2004 by LASALLE BUSINESS CREDIT, LLC, a Delaware limited liability company (the "Bank"), as successor in interest to MELLON BANK, N.A., in favor of VECTOR PRODUCTS, INC., a Florida corporation (the "Company").

PRELIMINARY STATEMENT

A. The Company granted to the Bank a security interest in certain of its trademarks, service marks and related property, as more particularly described on Exhibit "A" attached hereto (the "Intellectual Property"), in order to secure certain financing arrangements provided to the Company by the Bank (the "Financing Arrangement"). Such security interest in the Intellectual Property was recorded on **April 3, 2001** with the United States Patent and Trademark Office, at **Reel 2262, Frame 0535**.

B. All of the loans made by the Bank to the Company have been paid in full, and the Financing Arrangement has been terminated. The Bank therefore wishes to release the security interest granted in the Intellectual Property, to reassign the Intellectual Property to the Company and to provide the Company with evidence of such release and reassignment in a form capable of recordation with the United States Patent and Trademark Office.

In consideration of the premises set forth herein and for other good and valuable consideration, the Bank hereby agrees as follows:


1. The Bank hereby releases its security interest in, to and under the Intellectual Property and reassigns all its right, title and interest in, to and under the Intellectual Property to the Company, without recourse.

2. This Release and Reassignment shall be governed by and construed and enforced in accordance with the laws of the State of New York.
