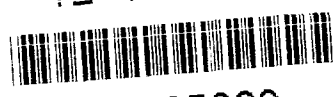

WHEREAS, **ASTROFLEX INC.**, a Canadian corporation (herein referred to as "Astroflex"), entered into a Trademark and Patent Security Agreement dated on or about July 20, 2001 (the "Agreement") in favor of the **BANK OF MONTREAL**, a Canadian chartered bank (herein referred to as the "Bank"); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank does hereby release any and all security interests in the Collateral and does hereby re-assign unto Astroflex the Collateral.


