**SECOND AMENDMENT TO COLLATERAL ASSIGNMENT  
OF TRADEMARKS (SECURITY AGREEMENT)**

THIS SECOND AMENDMENT TO COLLATERAL ASSIGNMENT OF TRADEMARKS (SECURITY AGREEMENT) (this "Amendment") is entered into by and between Wham-O, Inc., a Delaware corporation ("Pledgor"), with offices at 5903 Christie Avenue, Emeryville, California 94608, and Congress Financial Corporation (Western), a California corporation ("Pledgee"), with offices at 251 South Lake Avenue, Suite 900, Pasadena, California 91101. Initially capitalized terms used herein shall have the meanings ascribed thereto in the Agreement (as defined below).

RECITALS

WHEREAS Pledgor and Pledgee are parties to that certain Collateral Assignment of Trademarks (Security Agreement) dated January 10, 2001 and recorded with the U.S. Patent and Trademark Office on January 22, 2001 at Reel 002218, Frame 0475, as amended (the "Agreement"), pursuant to which Pledgor granted to Pledgee a security interest in all current and future Trademarks;



WHEREAS Pledgor has acquired New Trademarks and Pledgee has been made aware of the presence of the New Trademarks;


