**Declaration of Ownership Responsive to Erroneous Information
in Previously Recorded Assignment Documents**

I, the undersigned, declare that Meteor Crater Enterprises, Inc., an Arizona corporation with a current mailing address at Post Office Box 70, Flagstaff, Arizona 86002-0070, is the true, correct and only owner of the above-identified U.S. Registration No. 2,124,911 issued December 30, 1997. I hereby confirm that Meteor Crater Enterprises, Inc. is the original Registrant and continues to be the true, correct and only owner of the subject registration.

In December of 2003, Registrant timely filed its "Combined Declaration of Use and Incontestability Under Sections 8 and 15 of the Trademark Act" with the U.S. Patent and Trademark Office (USPTO) with respect to the captioned registration. On March 18, 2004, the USPTO's Post Registration Division issued an Office Action stating that Registrant's Combined Declaration was being refused because "It is unclear whether the party who filed the Section 8 Affidavit is the current owner." The USPTO's online "Trademark Assignment Abstract of Title" shows that a series of four merger and assignment documents were erroneously recorded by the USPTO on May 30, 2000 and February 23, 2001, apparently owing to a typographical error in one of the registration numbers listed on the recordation coversheets submitted by Lauren Seeger of HBO & Company and McKesson HBOC.
