THIRD: The certificate of incorporation of the Company (the "Certificate") is hereby amended by striking section 1 thereof and by substituting in lieu of said section the following new section:


"(1) The name of the Corporation is Inet ATS, Inc."

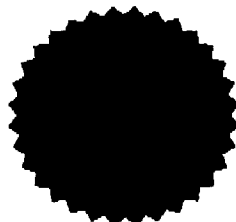
