TRADEMARKS ASSIGNMENT

THIS ASSIGNMENT OF TRADEMARKS, dated as of February 28, 2003 (this "Assignment"), by Nevamar Company, LLC ("Assignor"), a Delaware limited liability company with its principal place of business at 8339 Telegraph Road, Odenton, Maryland 21113 in favor of Industrial Laminates/Norplex, Inc. ("Assignee"), an Iowa corporation with its principal place of business at c/o Industrial Dielectrics, Inc., 407 South 7th Street, Noblesville, Indiana 46060.

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of February 14, 2003 (the "Purchase Agreement"), pursuant to which Assignor has agreed to transfer to Assignee and Assignee has agreed to accept from Assignor certain of the assets including, but not limited to certain trademarks, trade names, labels and other trade dress and copyrights (including goodwill associated therewith), exclusively relating to the Business and to become the successor to such Business or portion thereof to which any U.S. trademark applications filed on the basis of "intent-to-use" relate, which Business is ongoing and existing.



- (i) the trademarks set forth on Schedule A hereto, including all registrations and applications thereof, all registrations which may be granted in respect of such applications, all renewals of such registrations, and all common law rights therein;
- (ii) the goodwill of the business symbolized by such trademarks;
- (iii) all causes of action, claims and demands or other rights for, or arising from, and infringement, including past infringement, of such trademarks;
- (iv) all rights corresponding thereto throughout the world, and
- (v) all prosecution history files for such trademark registrations and applications for trademark registration in the possession of Assignor as well as records, prototypes, specimens, and materials contained in such files.

From time to time after the date hereof for a commercially reasonable time period after the Closing, at the request of either party hereto, and at the expense of the party so requesting, each of the parties hereto shall execute and deliver to such requesting party such documents and take such other action as such requesting party may reasonably request in order to consummate more effectively the transactions contemplated hereby.
