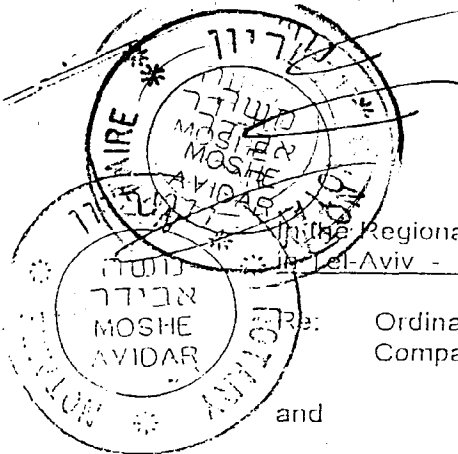

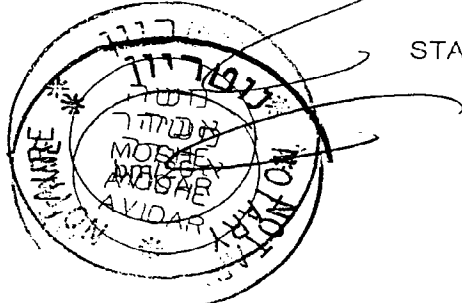

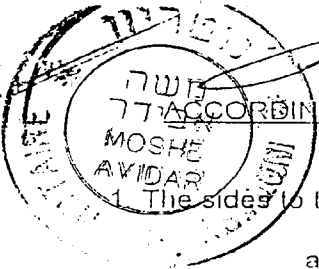

MERGE PLAN
ACCORDING TO PARAGRAPHS 223 AND 234 OF THE ORDINANCE OF COMPANIES
(NEW VERSION), 5743-1983



1. The sides to the merge:

- a. Ormat Turbines (1965) Ltd. (below-"Ormat Turbines").
- b. Ormat Industries Ltd. (below-"Ormat Industries").

2. Ormat Turbines, as the transferring company, will merge into Ormat Industries, as the acquiring company.

3. a. all the factory, assets and debts of Ormat Turbines will be transferred to Ormat Industries;

b. without retracting from what has been stated in sub-paragraph a. above - all the liabilities registered under Ormat Turbines and its assets (excluding liabilities whose term has expired, if such exist) will be transferred to Ormat Industries and its assets, replacing liabilities of Ormat Turbines as stated, and in order for this the necessary registers in the liability register of Ormat Turbines and in the registries of the Registrar of Companies will be carried out;

c. Ormat Industries will continue in its name or against the Company all legal proceedings (including arbitration) pending in the name of Ormat Turbines or against the Company;

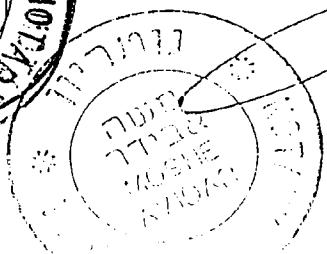
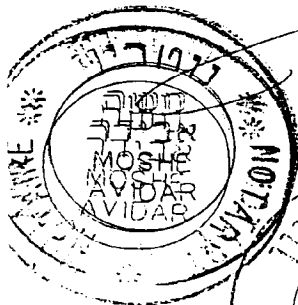
d. Ormat Industries will undertake the responsibility of compensation of retirement vis-a-vis all workers of Ormat Turbines in a manner that Ormat Turbines be exempt from payment of the compensation and in a manner that as far as the Law of Retirement Compensation, 5723-1963 is concerned the period of their work of the workers at Ormat Turbines will be considered as if they worked at Ormat Industries, and Ormat industries will give a written obligation vis-a-vis Ormat Turbines workers on this;

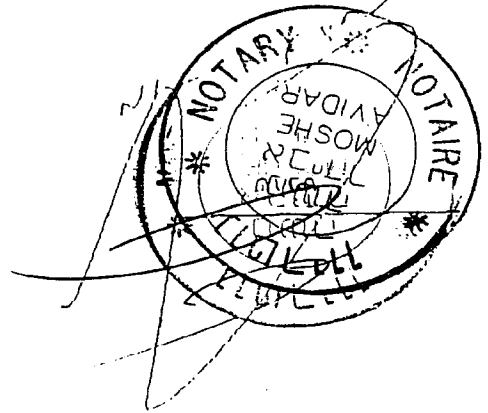
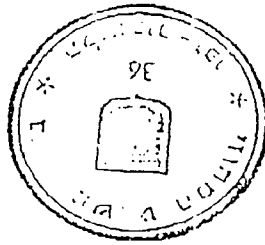
e. all its business and its transactions of Ormat Turbines, commencing from the day 1.1.92, will be and considered as business and as transactions that are made and carried out by Ormat Industries, and on its account, for its asset and for the liability of Ormat Industries;

f. Ormat Turbines will be terminated without being liquidated;

g. all the steps and signature on all the necessary documentation will be carried out for processing the instructions included in this plan and all additional items necessary for efficient and valid processing.

This plan enters into validity immediately after the authorization by the Court in accordance with paragraphs 233 and 234 of the Ordinance of Companies.
