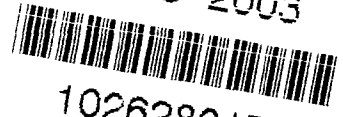


ASSIGNMENT OF U.S. TRADEMARK APPLICATIONS
