**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARK**

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and sufficiency of which are hereby acknowledged, Terphane Inc., a Delaware corporation (the "Grantor"), with principal offices at 2754 West Park Drive, Bloomfield, New York 14469, hereby grants U.S. Bank National Association, as Collateral Agent, with offices at 60 Livingston Avenue, St. Paul, Minnesota 55107 (the "Collateral Agent"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademark (the "Trademark") set forth on Schedule A attached, together with (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) thereof and (iii) all causes of action arising prior to or after the date hereof for infringement of the Trademark.

**THIS GRANT** is made to secure the satisfactory performance and payment of all the Secured Obligations, as such term is defined in the Security Agreement, dated as of June 9, 2004 (as amended from time to time, the "Security Agreement"), by the Grantor and the other debtors which from time to time become parties thereto in favor of the Collateral Agent. Upon the termination of the Security Agreement pursuant to Section 9 thereof, the Collateral Agent shall, at the request and expense of the Grantor, execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Trademark acquired under this Grant.


This Grant is being made in conjunction with the security interest granted to the Collateral Agent under the Security Agreement. The rights and remedies of the Collateral Agent with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Security Agreement, all relevant terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


