TRADEMARK AND DOMAIN NAME ASSIGNMENT

This TRADEMARK AND DOMAIN NAME ASSIGNMENT (this "*Assignment*") is made and entered into as of March 11, 2004, by and among Electronics For Imaging, Inc., a Delaware corporation ("*Assignor*") and VeriSign, Inc., a Delaware corporation ("*Assignee*").

WHEREAS, the Assignor and the Assignee are parties to that certain Purchase Agreement, dated as of February 23, 2004 (the "*Purchase Agreement*"), pursuant to which the Assignee has acquired all of the Assignor's right, title and interest in and to all of the trademarks, service marks, and trade names, together with the good will associated with and symbolized by them, as well as the domain name registrations, all as defined in the Purchase Agreement, listed in Schedule I hereto (all such trademarks, service marks, trade names, and domain name registrations referred to collectively as the "*Assigned Trademarks*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and the Assignee each hereby agree as follows:

1. Assignment. Assignor hereby sells, assigns, transfers, conveys and delivers to the Assignee and its successors and assigns, and the Assignee hereby purchases and accepts from the Assignor, all of Assignor's right, title and interest in, to and under the Assigned Trademarks, including, without limitation, all common law trademarks for the Assigned Trademarks for which no applications or registrations exist, all applications to register any of the Assigned Trademarks, and any registrations that have been or may be granted for any of the Assigned Trademarks, together with all common law rights associated with such applications and registrations, and all goodwill associated with the Assigned Trademarks and symbolized thereby, together with the right to sue and recover damages for future, present and past infringements of the Assigned Trademarks and to fully and entirely stand in the place of the Assignor in all matters related to the Assigned Trademarks.

2. Further Assurances. The Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required to effect the terms of this Assignment and its recordation in any relevant state and national trademark offices, and with relevant domain registrars.

3. Miscellaneous. This Assignment shall be governed by, and construed in accordance with, the laws of the State of California without reference to such state's principles of conflicts of law. This Assignment may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors.


