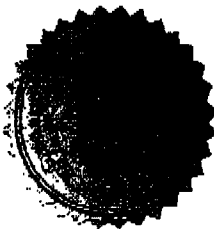

The undersigned, Papa Murphy's International, Inc., a Delaware corporation formed and existing under and by virtue of the General Corporation Law of the State of Delaware, hereby certifies as follows:

FIRST: The name and jurisdiction of formation or organization of each of the constituent corporations which is to merge are as follows:

Papa Murphy's International, Inc. (the "Merging Corporation")	Washington
Papa Murphy's International, Inc. (the "Surviving Corporation")	Delaware

SECOND: An Agreement and Plan of Merger providing for the merger of the Merging Corporation with and into the Surviving Corporation has been approved, adopted, certified, executed and acknowledged by the Merging Corporation and the Surviving Corporation in accordance with the requirements of Section 252 of the Delaware General Corporation Law.

THIRD: The name of the Surviving Corporation is "Papa Murphy's International, Inc."

FOURTH: The Certificate of Incorporation of the Surviving Corporation, as in effect immediately prior to the merger, shall be the Certificate of Incorporation of the Surviving Corporation.

SIXTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.

SEVENTH: The merger of the Merging Corporation with and into the Surviving Corporation shall be effective upon the filing of this Certificate of Merger.
