
RELEASE OF SECURITY INTEREST

Pursuant to Purchase and Sale Agreements, dated as of November 21, 2002, LJ Scanner Holdings, Inc. purchased the indebtedness from the lenders under that certain Amended and Restated Credit Agreement (the "Credit Agreement"), dated as of April 13, 2001, as amended, among PSC Scanning, Inc., as borrower, PSC, Inc., as guarantor, the lenders party thereto and Fleet National Bank (formerly known as Fleet Bank), as administrative agent (the "Secured Party").
