TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 19, 2003, by JPMorgan Chase Bank (formerly known as The Chase Manhattan Bank), a New York banking corporation, as Collateral Agent ("**Collateral Agent**").

WITNESSETH:

WHEREAS, Collateral Agent and ACMI Corporation, a Delaware corporation ("**ACMI**,"), were parties to that certain Security Agreement Supplement dated as of April 2, 2003 (the "**Security Agreement Supplement**") to the Security Agreement dated as of November 12, 1999 among Collateral Agent, ACMI, American Cystoscope Makers, Inc. and the subsidiaries of ACMI listed therein (the "**Security Agreement**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which ACMI granted a security interest to Collateral Agent in, and a collateral assignment to Collateral Agent of, among other things, the Trademarks (as defined in the Security Agreement), including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, the Security Agreement Supplement was recorded by the Assignment Division of the United States Patent and Trademark Office on April 8, 2003, at Reel 002707/ Frame 0246; and

WHEREAS, ACMI has requested that Collateral Agent release its security interest in the Trademarks and reassign the same to ACMI;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its security interest in all of ACMI's right, title and interest in and to all of the following:

(a) each Trademark, Trademark registration and Trademark application, including, without limitation, the Trademarks, Trademark registrations (together with any reissues, continuations or extensions thereof) and Trademark applications referred to in Exhibit A annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;

(b) each Trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and

(c) all products and proceeds of the foregoing, including, without limitation, any claim by ACMI against third parties for past, present or future (a)

2. Collateral Agent hereby reassigns, grants and conveys to ACMI, without any representation, recourse or undertaking by Collateral Agent, all of Collateral Agent's right, title and interest in and to the Trademarks, and the goodwill of ACMI's business connected with the use of and symbolized by the Trademarks.
