Logitech, Inc. hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

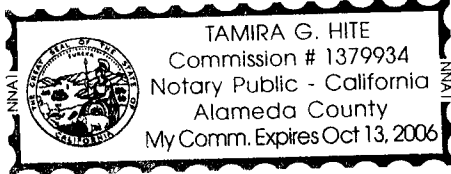
