ASSIGNMENT OF UNITED STATES TRADEMARK RIGHTS

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR has agreed to and does hereby assign unto the said ASSIGNEE whatever right, title and interest ASSIGNOR owns in and to said TRADEMARK RIGHTS together with the goodwill of the business in connection with which the TRADEMARK RIGHTS are used and which is symbolized by the TRADEMARK RIGHTS, along with the right to recover for damages and profits for past infringements thereof;

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the TRADEMARK RIGHTS to ASSIGNEE in accordance with the terms of this instrument.

ASSIGNOR does not warrant the validity of the TRADEMARK RIGHTS.


