## ASSIGNMENT

WHEREAS, MICHAEL J. RUTLEDGE and KRISTINE M. SCHOENAUER, individuals residing at 475 N. Sheridan Street, Corona, California, 91720 hereinafter referred to as the "Assignors" are the owners of the of the trademarks listed on Attachment A hereto, hereinafter the "Trademarks", for use in association with goods and services as identified on Attachment A, hereinafter "Goods and Services";

WHEREAS, the Assignors have duly licensed the Trademarks to Earth Science, Inc., a California corporation, for use in association with the Goods and Services and have retained all rights in the Trademarks with all benefits of use thereof inuring to the Assignors;

WHEREAS, Terrapin Companies, a California corporation having a business address of P.O. Box 40339, Santa Barbara, CA 93140, as buyer and Schoenauer Charitable Remainder Unitrust Number 1, Schoenauer Charitable Remainder Unitrust Number 2, , Rutledge Charitable Remainder Unitrust, and Earth Science, Inc., a California corporation, all having a business address c/o Earth Science, Inc., 475 N. Sheridan Street, Corona, CA 91720, jointly as Sellers have entered into that certain Purchase Agreement dated September 13, 2002 for purchase of certain assets by Terrapin Companies, including the rights Trademarks as defined therein;

WHEREAS, Terrapin Companies, hereinafter referred to as "Assignee", has acquired from Sellers all rights in and to the manufacture, marketing and sale of the Goods and Services previously conducted by the Sellers in the United States and desires to acquire the entire right, title and interest in and to said Trademark(s) and all goodwill associated therewith from the Assignors for use in association with the Goods and Services and any and all trademark registrations which may be granted thereon in the United States;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged by Assignors,

1. Assignors hereby sell, assign, transfer and convey to Assignee all right, title and interest in and to said Trademarks in the United States, including any registrations or applications for registration thereof with any divisions, substitutions, conversions, reissues, additions, renewals or extensions thereof, and including the right to sue for any past infringements thereof, said interest to be held and enjoyed by Assignee as fully and exclusively as it would have been held and enjoyed by said Assignors had this Assignment and transfer not been made.

2. Assignors hereby covenant, warrant and represent that they have not heretofore granted any license, right or privilege with respect to the Trademarks or any applications for registration or registrations thereof, or in any other way encumbered the same, except as defined herein, and that they have the full right to make this Assignment.

3. Assignors further agree that at the request and expense of Assignee, but without charge to said Assignee, they will promptly execute all papers necessary or desirable to perfect ownership of the Trademarks or any applications for registration or registrations thereof, in said Assignee, and will execute all oaths and other papers, within the truth, that are necessary or desirable for prosecuting any application for registration, for use in any litigation or other proceedings involving the Trademarks or any applications for registration or registrations thereof, for refilling said applications, for filing of renewals or other applications which are deemed necessary or desirable by Assignee, or for the filing in foreign countries of applications for registration of the Trademarks.

4. The terms covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignors, their heirs, legal representatives and assigns.

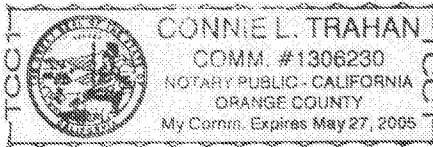
