Said Kinetic Systems, Inc., its successors and assigns, shall have, hold and enjoy the said trademarks to its and their own use, including the right to sue for past infringement.

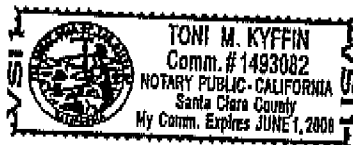
