AFFIDAVIT OF DONALD L. CARANO

DONALD L. CARANO, being first duly sworn, deposes and says:

1. The owner of SILVER BARON, U.S. Reg. No. 2,032,577, is Circus and Eldorado Joint Venture, a Nevada general partnership.

2. The document previously recorded at Reel/Frame No. 1571/0590, recorded March 24, 1997, contains a typographical error made by the Office which incorrectly states that Circus and Eldorado Joint Venture is a Nevada corporation.

3. SILVER BARON, U.S. Reg. No. 2,032,577, was registered by Circus Circus Enterprises, Inc., a Nevada Corporation on January 21, 1997. This registration was later assigned to Circus and Eldorado Joint Venture, a Nevada general partnership. The assignment to Circus and Eldorado Joint Venture was recorded with the Office on March 24, 1997.

4. The assignment document correctly sets out that Circus and Eldorado Joint Venture is a Nevada general partnership. Likewise, the coversheet to the Office correctly sets out that Circus and Eldorado Joint Venture is a Nevada general partnership. However, the recordation sheet from the Office incorrectly states that Circus and Eldorado Joint Venture is a Nevada corporation.

5. Furthermore, the document previously recorded at Reel/Frame No. 1954/0317, recorded September 9, 1999, was filed inadvertently when the previous owner of SILVER BARON, U.S. Reg. No. 2,032,577, Circus Circus Enterprises, Inc., changed its name to Mandalay Resort Group.

6. Because Circus Circus Enterprises, Inc. did not then own SILVER BARON, U.S. Reg. No. 2,032,577, the change of corporate name should not have been recorded against this

registration.

7. Accordingly, the owner of SILVER BARON, U.S. Reg. No. 2,032,577, is Circus and Eldorado Joint Venture, a Nevada general partnership.
