### TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR possesses in and to the Trademark set forth in Schedule A and the Registration set forth in Schedule B, together with certain intangible assets associated with said Trademark and Registration, including, but not limited to, the goodwill symbolized by said Trademark and that portion of the business of ASSIGNOR to which the Trademark pertains.
