ASSIGNMENT OF TRADEMARKS
AND RELEASE OF ALL INTERESTS THEREIN

WHEREAS, pursuant to the terms of a Trademark Collateral Assignment agreement dated May 7, 1993 (the "Agreement"), Specialty Brands of America, Inc., a Massachusetts corporation having a usual place of business at 24 East Ave., New Canaan, CT 06840 ("Specialty Brands"), assigned to US Trust, a Massachusetts corporation having had a usual place of business at 30 Court Street, Boston, MA 02108 ("US Trust"), the marks set forth in Exhibit A attached hereto, now registered with the United States Patent and Trademark Office (the "Marks");

WHEREAS, Citizens Bank of Massachusetts, a Massachusetts bank ("Citizens Bank") having a usual place of business at 28 State Street, Boston, MA 02109, is successor by merger to US Trust;

WHEREAS, Paragraph 4 of the Agreement provides that, upon payment in full of the obligations incurred by Specialty Brands under the Agreement (the "Obligations"), Citizens Bank, as successor by merger to US Trust, shall reassign the Marks to Specialty Brands;

WHEREAS, Specialty Brands has satisfied the Obligations in full;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Citizens Bank hereby assigns to Specialty Brands all right, title and interest it may now have, may ever have had or may ever have, in and to the Marks and the good will symbolized thereby, and releases all interests in the Marks.

The Assignor further agrees that Assignor will, without demanding any further consideration therefore, at the request but at expense of the Assignee, do all lawful and just acts, including the execution and acknowledgement of instruments, that may be or become necessary for obtaining, sustaining, or renewing the Marks, and for maintaining and perfecting the Assignee's right to the Marks.

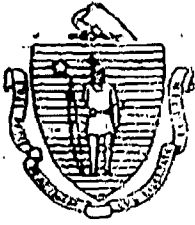

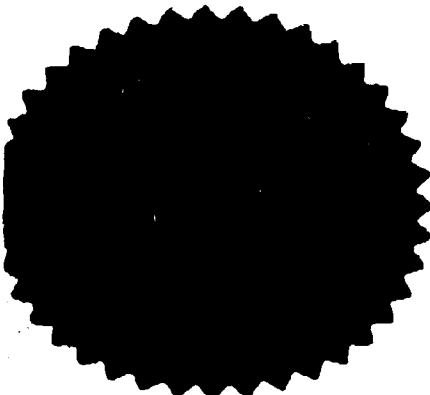
