SONOCO hereby further agrees to execute all applications, assignments, lawful oaths, powers of attorney and any other papers and do all other lawful acts which HILEX may reasonably deem to be necessary or desirable for securing to HILEX or for maintaining for HILEX the Trademarks hereby assigned, all without further compensation to SONOCO.

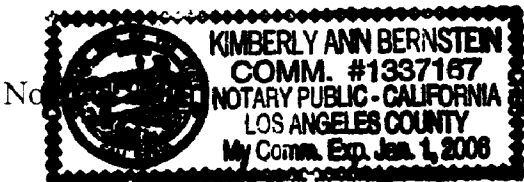
