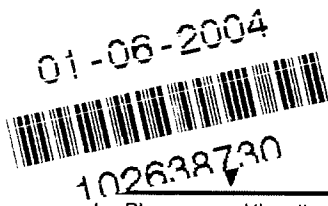

RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") dated December 23, 2003 is made by AIG Highstar Capital, L.P. ("AIG"), 175 Water Street, 26th Floor, New York, New York 10038 and Industrial Technology Ventures, L.P. ("ITV"), each acting in its capacity as collateral agent (in such capacity, the "Collateral Agents") for the holders (including AIG and ITV, collectively, the "Noteholders") of certain convertible secured promissory notes (collectively, the "Notes") under a Security, Intercreditor and Collateral Agency Agreement dated as of July 9, 2003 (the "Agreement"), by and among Skybitz, Inc., a Delaware Corporation, ("Debtor") and the Noteholders.

W I T N E S S E T H:

WHEREAS, pursuant to the Agreement, the Debtor granted to the Collateral Agents security interests in certain of the Debtor's intellectual property interests as described on Schedule A attached hereto (collectively referred to herein as the "Trademarks") to secure the payment and performance by the Debtor of certain of its obligations.

WHEREAS, the Collateral Agents represent that (i) they are the sole Collateral Agents authorized in the Agreement and (ii) to the best of each Collateral Agent's knowledge, the Agreement is the only instrument by which a security interest in the Trademarks has been granted to the Collateral Agents or to any Noteholder.

WHEREAS, the Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office, on August 7, 2003, located on Reel 002695, Frame 0954.

WHEREAS, the Collateral Agents, acting in such capacity on behalf of the Noteholders, wish to: (i) terminate the Agreement and release all of the Collateral Agents' security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtor; and (iii) dissolve any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agents do hereby: (a) terminate the Agreement and release the Collateral Agents' security interests in the Trademarks, any trademarks or trademark applications claiming priority thereto, and to any later acquired trademarks or trademark applications, (b) discharge, quit claim and relinquish unto the Debtor (in each case without recourse and without any representation or warranty) any and all rights, title and interest the Noteholders or Collateral Agents have in and to the Trademarks, any trademarks or trademark applications claiming priority thereto, and to any later acquired trademarks or trademark applications, and (c) authorize the Debtor or its designees to take all actions such person or entity deems necessary or desirable to terminate any other filings recording the security interests released herein, including filing UCC termination statements.
