

For the above consideration, Assignor agrees that upon request of the Assignee, its successors or assigns, it shall execute and deliver any papers which may be necessary or desirable fully to secure to the Assignee, its successors and assigns, the Mark and any rights therein.

IN WITNESS WHEREOF, Assignor, by its duly authorized officer, does hereby execute this Trademark Assignment effective as of the 11th day of June, 2004.
