

ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, for good, valuable and lawful consideration, the receipt of which from Buyer is hereby acknowledged by Seller, Seller does hereby:



And for the same consideration, Seller hereby covenants and agrees to and with Buyer, its successors, legal representatives and assigns, that Seller will, whenever counsel of Buyer, or the counsel of its successors, legal representatives and assigns, shall advise that it is lawful and desirable, sign all papers and documents, deliver necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts necessary or desirable to be done for the procurement, maintenance, enforcement and defense of said Mark and registrations thereof.



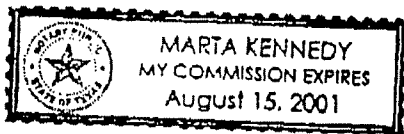
