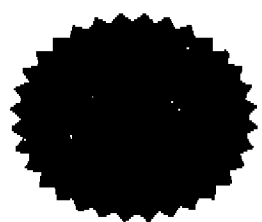

The undersigned limited liability company formed and existing under and by virtue of the Delaware Limited Liability Company Act, 6 Del. C. §18-101, et seq. (the "Act"), DOES HEREBY CERTIFY AS FOLLOWS:

FIRST: The name and state of formation or organization of each of the constituent entities to the merger (the "Constituent Entities") is as follows:
