WHEREAS, THE TRUSTEE OF THE SECOND BELL BOYS IRREVOCABLE TRUST (hereinafter the SECOND TRUST), a trust created under the laws of the Commonwealth of Pennsylvania and having an address at 978 Easton Road, Warrington, Pennsylvania 18976, with STUART R. CHALFIN as Trustee (hereinafter SECOND TRUSTEE), said STUART R. CHALFIN being a citizen of the United States and having an address at 8010 Old York Road, Elkins Park, Pennsylvania 19117, is desirous of acquiring for said SECOND TRUST as of May 31, 1997 all of the right, title and interest of the ORIGINAL TRUSTEE in and to said trademarks and services marks, the goodwill of the business associated with and symbolized by the trademarks and service marks, the Certificates of Registration and applications for registration thereof.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged by the ORIGINAL TRUSTEE, the ORIGINAL TRUSTEE does hereby confirm that effective as of May 31, 1997 he sold, assigned and transferred to the SECOND TRUSTEE and by these presents does hereby sell, assign and transfer to the SECOND TRUST, the trademarks and service marks listed in Schedule A, the goodwill of the business associated with and symbolized by the trademarks and service marks, and the Certificates of Registration and applications for registration therefor, as identified in Schedule A.

Included in this Assignment are any and all rights which the ORIGINAL TRUSTEE has, or may have had, against persons who have infringed upon any of said trademarks, service marks, Certificates of Registration or applications for the registrations therefor prior to the effective date of this Assignment. These rights include the right to sue and recover for all damages and profits arising out of infringement of the trademarks, service marks, and the registrations and applications for registrations thereof, prior to the effective date of this Assignment.
