TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 22, 2003, by **MANUFACTURERS HANOVER TRUST COMPANY** (“**Bank**”).

WITNESSETH:

WHEREAS, Bank and Carvel Corporation, a Delaware corporation (“**Grantor**”), were parties to a security agreement dated January 2, 1991 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Bank in certain trademarks (the “**Trademarks**”), as security for certain obligations owing by Grantor to Bank, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Assignment Division of the United States Patent and Trademark Office on January 29, 1991, at Reel 0773, Frame 0009; and

WHEREAS, Grantor has requested that Bank release its security interest in the Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in all of Grantor’s right, title and interest in and to all of the following:

(i) each Trademark listed on Schedule 1 annexed hereto, together with any applications, registrations or renewals thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark;

(ii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any Trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest in and to the Trademarks, and the goodwill of Grantor’s business connected with the use of and symbolized by the Trademarks.
