

The name of the Corporation shall be Johnson Outdoors Inc.

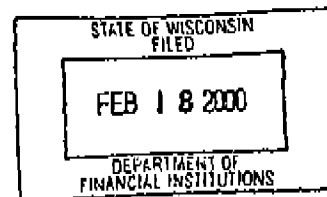
