RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of June 30, 2003 (this "Release") is made by TORONTO DOMINION (TEXAS), INC., as Administrative Agent ("Agent"), acting in its capacity as secured party (in such capacity, the "Secured Party") under the Senior Subordinated Trademark Security Agreement, dated as of October 8, 2002 and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among METROCALL USA, INC., a Delaware corporation, (the "Debtor") and the Secured Party;

WITNESSETH:

WHEREAS, pursuant to the Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Debtor granted to the Secured Party a continuing security interest in all of the Debtor's United States Intellectual Property Collateral including those set forth on the attached schedules;

WHEREAS, the Secured Party wishes to: (i) terminate the Security Agreement against the Intellectual Property Collateral including those identified in the attached schedules hereto, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Intellectual Property Collateral including those listed in the attached schedules; (iii) restore all right, title and interest in and to the Intellectual Property Collateral including those listed in the attached schedules, to Debtor; and (iv) to dissolve any and all liens and encumbrances respecting the Intellectual Property Collateral including those listed in the attached schedules.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Intellectual

Property Collateral including those set forth on the attached schedules hereto, and discharges, quit claims and relinquishes unto METROCALL USA, INC., (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral including those listed in the attached schedules.
