



BETWEEN:

- (1) **BIOGLAN PHARMA PLC (in liquidation)** a company incorporated in England and Wales with number 1779870 whose registered office is at Becket House, 1 Lambeth Palace Road, London SE1 7EU acting by the Liquidators as agent for Bioglan Pharma Plc (the "Assignor");
- (2) **DAVID KENNETH DUGGINS and IAN BEST** both of Becket House, 1 Lambeth Palace Road, London SE1 7EU (the "Liquidators"); and
- (3) **BIOGLAN AB** (organisation no. 556480-0224) a company incorporated under the laws of Sweden whose office is at Borrगतan 31, SE-202, 13 Malmö, Sweden (the "Assignee")

THE PARTIES AGREE AS FOLLOWS:

1. In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor does **HEREBY ASSIGN** and transfer to the Assignee all its right, title and interest in the trade marks set out in the schedule hereto (the "Trade Marks") including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action.
2. The Assignor confirms that this assignment is made with any goodwill attaching to the Trade Marks and any goodwill of the business in which the Trade Marks have been used by the Assignor.
3. The Assignor shall at the expense of the Assignee do and execute or procure that there shall be done and executed all such documents, deeds, matters, acts and things as the Assignee may reasonably require in order effectively to give the Assignee the benefit of this assignment.
4. The Assignee acknowledges that:
 - (a) the Liquidators' knowledge of the Trade Marks is limited and that some of the Trade Marks may be subject to claims by third parties. If it is found that the Assignor does not have title or unencumbered title to any of the Trade Marks purported to be assigned hereby, the Assignee expressly agrees that it shall have no right to rescind this assignment or to claim damages whether against the Assignor or the Liquidators;
 - (b) the Assignor enters into this assignment only upon the express agreement of the Assignee that all warranties, conditions, guarantees or representations, express or implied, statutory or otherwise, relating to any of the Trade Marks are excluded and the Assignor shall not be liable for any loss, damage or injury of any kind whatsoever arising out of or due to or caused by any defect or deficiencies of any sort in any of the Trade Marks;

- (c) the Assignee is not acting in reliance upon any representation made to it by the Assignor or the Liquidators or any of their respective agents or employees but is relying solely on its own investigations in entering into this assignment; and
 - (d) the Liquidators shall have no personal liability under this Assignment and that for the avoidance of doubt the Liquidators are agents of the Assignor and act in that capacity in the negotiation, preparation and implementation of this assignment.
5. This assignment (and any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to this assignment or its formation) shall be governed by and construed in accordance with English law.
6. Each of the parties to this assignment irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to hear and decide any suit, action or proceedings and/or to settle any disputes which may arise out of or in connection with this assignment and, for these purposes, each party irrevocably submits to the jurisdiction of the courts of England and Wales.




