

ASSIGNMENT OF UNITED STATES TRADEMARK REGISTRATION

WHEREAS, WEISER LOCK CORPORATION, a corporation organized and existing under the laws of the State of California, having its principal office address at 6700 Weiser Lock Drive, Tucson, Arizona 85746, (hereinafter the "Assignor"), is the owner of United States Trademark Registration No. 1793163;

WHEREAS, THE BLACK & DECKER CORPORATION, a corporation organized and existing under the laws of the State of Maryland, having its principal office address at 701 E. Joppa Road, Towson, Maryland 21286, (hereinafter, the "Assignee"), is desirous of acquiring the entire right, title and interest of the Assignor in and to said United States Trademark Registration No. 1793163, and the goodwill associated therewith;

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration not herein specifically enumerated, the receipt and sufficiency of which is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does hereby sell, assign and transfer unto the Assignee, its successors, assigns or other legal representatives, its entire right, title and interest including the goodwill associated therewith, to the said United States Trademark Registration No. 1793163, together with all rights thereunder as the same would have been held by the Assignor had this Assignment and sale not been made.

The foregoing sale, assignment and transfer shall include all claims for profits and damages by reason of past infringement, of said United States Trademark Registration, with the right to sue for and collect the same for the Assignee's own use and advantage and for the use and advantage of its successors, assigns or other legal representatives.
