IRREVOCABLE ASSIGNMENT OF INTANGIBLE PROPERTY RIGHTS

THIS IRREVOCABLE ASSIGNMENT OF INTANGIBLE PROPERTY RIGHTS (this "Assignment") as made as of this 6th day of January, 2004 between TalkPoint Communications, Inc., a Delaware corporation, *f.k.a.* Video Network Communications, Inc. ("Assignor") and DTS Video Holdings, Inc., a Virginia corporation ("Assignee"), a wholly owned subsidiary of Dynamic Technology Systems, Inc., a Virginia corporation, its successors and assigns.

This Assignment is made pursuant to that certain Asset Purchase Agreement (the "Agreement") dated January 6, 2004, between Assignor and Assignee.

WHEREAS, Assignor is the owner of the Intangible Property (as defined in the Agreement); and

WHEREAS, Assignor desires to assign and Assignee desires to assume all of Assignor's right title and interest in and to the Intangible Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Agreement, Assignor does hereby sell, assign and transfer unto Assignee, its successors, assigns and legal representatives, Assignor's entire worldwide right, title and interest in and to the Intangible Property, including without limitation:
