TO THE TEXAS SECRETARY OF STATE:

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act and any amendment thereto or supplement thereof (hereinafter referred to as the "Act"), the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is:

QMI Medical, Inc.

hereinafter referred to as the "Corporation."

2. The following amendment to the Articles of Incorporation of the Corporation was adopted by the sole shareholder of the Corporation on June 18, 1998.

FIRST: Article 1 of the Articles of Incorporation is deleted in its entirety and the following substituted in lieu thereof:

1. NAME. The name of the Corporation is:

Quest Medical, Inc.

SECOND: Except as hereinabove amended, the Articles of Incorporation of the Corporation are continued in full force and effect.

3. The number of shares of the Corporation outstanding at the time of the adoption of the amendment was 1,000 and the number of shares entitled to vote thereon was 1,000.

4. The foregoing Amendment to the Articles of Incorporation of the Corporation was adopted by the sole shareholder and the directors of the Corporation on June 19, 1998 through the execution of a consent pursuant to Article 9.10 of the Texas Business Corporation Act, and any written notice required by Article 9.10 has been given.
