## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into as of the 13<sup>th</sup> day of July, 2004 by MedStar SportsHealth, LLC, a Maryland limited liability corporation, having its principal place of business at 100 Irving Street, NW, Washington, DC 20010 ("Assignor"), to MedStar Health, Inc., a Maryland corporation, having its principal place of business at 5565 Sterret Place, 5<sup>th</sup> Floor, Columbia, MD 21044 ("Assignee").

### WITNESSETH:

The parties hereby request that the Commissioner of Trademarks issue the certificate of registration for the pending trademark application listed on Schedule A in the name of the Assignee.

Assignor undertakes that upon the request of Assignee or its designees, it and/or its successor in business, shall make all rightful oaths, testify on behalf of Assignee or its designees in matters involving the Mark and do all other lawful acts necessary to carry out the intent of this Trademark Assignment as well as to provide such other material, information and assistance to Assignee or its designees, as may be considered necessary in connection therewith.
