INTELLECTUAL PROPERTY RELEASE

THIS RELEASE dated as of January 12, 2004, by JPMorgan Chase Bank as Collateral Agent for the Lenders (as such terms are defined below). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

WITNESSETH:

WHEREAS, TRW AUTOMOTIVE INC. (the "Borrower"), the LENDERS, and JPMORGAN CHASE BANK, a New York banking corporation, as administrative agent (in such capacity, the "Administrative Agent"), as collateral agent (in such capacity, the "Collateral Agent") are party to that certain Credit Agreement dated as of February 27, 2003, as amended and restated (the "Credit Agreement").

WHEREAS, the Borrower and the Domestic Subsidiary Loan Parties, including but not limited to Kelsey-Hayes Company, (together with the Borrower, the "Grantors") and the Collateral Agent are party to that certain Security Agreement dated as of February 28, 2003, as amended (the "U.S. Guarantee and Collateral Agreement"), recorded by the United States Patent and Trademark Office pursuant to which, among other things, certain Grantors granted a security interest to the Collateral Agent for the benefit of the Secured Parties in certain Collateral (as defined in the Security Agreement).

WHEREAS, in connection with the sale of the Autospecialty business pursuant to an Asset Purchase Agreement dated December 23, 2003 between Kelsey-Hayes Company and Universal Automotive Inc., the Collateral Agent has agreed to the release of record by the Collateral Agent of its interest in the Collateral owned by the Grantors described on Schedule I hereto;

NOW, THEREFORE, the Collateral Agent hereby fully releases of record the security interest in the Collateral and reserves no rights in the Collateral described on Schedule I attached hereto.
