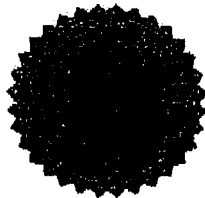





(the "GCL").

1. The Company's name immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was Elmer's Investments, Inc.
2.
